new Anthem quality measures

Anthem has significantly changed the network's scorecard for calendar year 2023. There are fewer quality measures and as a result each measure is weighted heavier. Well visits for 0-15 months and 3-6 years have been replaced with well visits 15-30 months. Also, the quality measures for varicella and pharyngitis have been removed.
